| SB1971 HB1666 | Beavers Stanley | S: Judiciary H: Judiciary | Real Property – Prohibits declarations and governing documents of common interest developments from limiting, prohibiting, or being construed to limit or prohibit, proper display of United States flag on owner's separately owned real property in exclusive use common areas; awards prevailing party reasonable attorneys' fees and costs. Amends TCA Title 13 and Title 66. | |
| SB1184 HB0242 | Crowe Hargett | S:Education H:Education | Education – Grants access to certain information about public high school students to official recruiting representatives of U. S. armed forces and Tennessee national guard. Amends TCA Title 49. | Oppose |
| SB1126 HB0670 | Cooper Maddox | S: Trans H: Trans | Special License Plates – Requires all special license plates be issued as one generic plate design and restructures issuance of such license plates to be through the department of safety instead of by specific legislative enactment. Amends TCA Title 55, Chapter 4. | Monitor |
| SB1117 HB0432 | Finney, et al Campfield, et al | S:Education H:Education | Education, Higher – Specifies students' rights to academic freedom, freedom from discrimination based on political or religious beliefs, and the right to information concerning grievance procedures; directs THEC to develop and enforce statewide institutional grievance procedure. Amends TCA Title 49, Chapter 7. | Oppose |
| SB0809 HB1432 | Burchett S. Jones, et al | S: Judiciary H: Judiciary | Domestic Violence – Requires rather than permits the records custodian of domestic violence shelters and rape crisis centers to keep records confidential unless the individual consents to release or there is a court-approved subpoena for the records. Amends TCA Title 36, Chapter 3, Part 6. | Support |
| SB0456 HB0532 | Hagood Casada | S: Trans H: Trans | Motor Vehicles, Titling and Registration – Requires that all future cultural or new specialty earmarked license plates be issued administratively by the department of safety rather than by enactment of the general assembly upon a group's payment for a | Monitor |
