ACLU-TN and Community Organizations Urge Court to Block Governor's Unconstitutional National Guard Deployment in Memphis

On Thursday, October 30, ACLU-TN, along with Memphis-based community organizations, filed an amicus brief in *Harris v. Lee*. The amicus brief supports the seven elected officials challenging Governor Bill Lee's deployment of the Tennessee National Guard to Memphis. Community leaders across Memphis are united in their demand for accountability, transparency, and respect for constitutional limits. "Stand for Children Tennessee joined this amicus brief because Memphis and Shelby County residents deserve transparency, accountability, and local control over how public safety decisions are made and carried out. Deploying the National Guard and federal agents without clear local consent undermines trust, weakens collaboration, and blurs lines of authority. Public safety must be rooted in community partnership and guided by those closest to the people it serves.

What is happening in Memphis reflects a larger threat to democracy across the country. When state and federal power override local authority, it endangers the principles of self-governance

and accountability that every community depends on. This lawsuit is a necessary step toward restoring that balance and ensuring that decisions about our city's safety remain accountable to Memphis and its residents."
