POLICE BRUTALITY AND MISCONDUCT

WHAT TO DO IF YOU HAVE BEEN CHARGED WITH A CRIME

ACLU-TN does not provide criminal defense, except in extremely rare circumstances. If you have been charged with a crime, your defense attorney is the best person to answer questions about due process and arrest procedures (use of search warrants, forced confessions, Miranda, information entrapment. etc.). All about the circumstances of the arrest should be related to your attorney, since it may affect the disposition of the charges. Document your claims by collecting written statements from witnesses, obtaining copies of your medical records if you received any injuries, and taking pictures of any injuries or damage to property. This information will be important if you decide to file a lawsuit.

You should not take any of the other steps described here until you have consulted with your defense attorneys. This is important because anything you say to a police office after having been read your rights can be used against you in court. If you cannot afford a lawyer and are charged with a crime that could result in jail time, you are entitled to a public defender.

COMPLAINTS TO INTERNAL AFFAIRS

If you have not already filed a complaint with the internal affairs department of your police department, you should do so. All complaints to the police should be made in writing, and copies of the complaint should also be sent to local district attorneys, city officials, the state attorney general, or the U.S. Department of Justice. The complaints should include as much detail as possible. The letter of complaint should include:

- A description of the incident;
- The time and place of the incident;
- The events which took place in the order in which they happened;
- The names and/or badge numbers of the officer(s) involved, or a physical description of the officer(s);

- The names, addresses, and telephone numbers of any witnesses to the incident;
- If medical treatment was required, the name of the examining doctor and/or the name of the hospital or clinic attended; and
- Prints of photographs taken of any injuries sustained in the incident.

Your letter should then detail the specific actions of the police officers that you wish to complain about and should conclude with what responses you wish to receive concerning the specific complaints. You can request an explanation from the police, a formal apology, disciplinary action against the officer(s) involved, monetary damages, or if you are not sure what actions you want taken, you can simply ask for a "full and reasonable" response to the complaint.

Remember to sign and date the letter, including your name, address, and phone number, and keep copies of all documentation and correspondence.

If your city has a civilian review board or a human relations/human rights agency, you should contact them. (See Attached List)

You should also send a copy of your complaint and a request for an investigation to:

If you are unsatisfied with the investigation conducted by local Internal Affairs Division, send a copy of their results to the Attorney General's office, state why you are dissatisfied with the results, and request a review of the local investigation.

Police can arrest you when:

• they have a warrant for your arrest;

- they see you violating, or attempting to violate, the law; or
- they have good reason to believe you violated the law

What the police can do when they arrest you:

- search your body;
- search your belongings;
- search your car (if you are in it when you get arrested); and
- search the space around you if you are at home. The police must show a search warrant before they can enter and search a home unless there are existing circumstances.

When you are arrested: Questioning

When you are arrested you may refuse to talk to the police or answer any questions, or sign any statements. You **MUST** be allowed to call a lawyer. If you cannot afford a lawyer, you can insist that a free lawyer be present during any police questioning.
