REPRODUCTIVE FREEDOM

Reproductive freedom is one of the most personal decisions we can make. All too often, discussions about reproductive rights seem mired in politics rather than focused on our daily lives. The government has great amounts of power to be able to dictate our private morality, which needs to be stopped. ACLU-TN is committed to protecting a woman's right to choose.

HISTORY

As early as 1923, the U.S. Supreme Court ruled that the Constitution protects personal decisions regarding marriage and the family from governmental intrusion. In 1965, the Court ruled that a state cannot prohibit a married couple from practicing contraception. In 1972, it extended the right to use birth control to all people, married or single. And in its 1973 ruling in *Roe v. Wade*, the Court held that the Constitution's protections of privacy as a fundamental right encompass a woman's decision to have an abortion.

The *Roe* decision, which legalized abortion nationwide, led to a dramatic improvement in the lives and health of women. Before *Roe*, women experiencing unwanted or crisis pregnancies faced the perils and indignities of self-induced abortion, back-alley abortion, or forced childbirth. Today, *Roe* protects the right of women to make life choices in keeping with their conscience or religious beliefs, consistent with American tradition. And by relieving American women of the burden of unwanted pregnancies, Roe has permitted them to pursue economic opportunities on a more equal basis with men.

The Tennessee Supreme Court held in the ACLU-TN case *Planned Parenthood v. Sundquist* that abortion was a fundamental right under the Tennessee Constitution.

In 2015, voters amended the Tennessee Constitution to overturn this decision, adding language to the constitution stating that abortion is no longer a fundamental, constitutionally-protected right in Tennessee. On the heels of the amendment's adoption, the Tennessee General Assembly established several new restrictions on abortion, including a 48-hour waiting period for women seeking an abortion.

TENNESSEE LAW

Though not a fundamental right under the Tennessee Constitution, Tennessee law does currently protect the right to an abortion until viability of the fetus. TCA §39-15-201(C). After viability, an abortion can only be performed if it is to protect the woman's life or health. In Tennessee every physician has the right to refuse to terminate a pregnancy.

PARENTAL CONSENT FOR MINORS

Tennessee law mandates that a minor (under the age of 18 and not emancipated) must have consent of at least one parent in order to get an abortion. This requirement can be waived however, with a court order. The process to obtain the court order is referred to as "Judicial Bypass Waiver."
