### SENIOR CITIZENS

#### AGE DISCRIMINATION

As a general rule, there are few civil liberties issues that primarily affect seniors over other individuals. However workers aged 40 and over are protected against age discrimination on the job. The federal Age Discrimination Employment Act (ADEA) applies to employers of 20 or more people. Private businesses, units of government, unions and employment agencies are all subject to its provisions. The ADEA also prohibits age discrimination in programs and activities receiving federal money, such as public agencies, hospitals, nursing homes, day care centers and other social service providers.

The Tennessee Human Rights Act also protects against age-related discrimination with regards to employment practices and public accommodations

#### NURSING HOMES

Although nursing homes can impose reasonable rules that residents are expected to respect, residents do not give up legal rights or civil liberties upon entering a nursing home. Nursing home residents have the right to:

- □ Vote
- □ Marry
- □ Enter into contracts
- □ Exercise their first amendment rights, including the right to speak out about conditions at the nursing home.
- Privacy: residents are entitled to privacy in dressing, bathing and using the toilet, and are entitled to keep a reasonable number of personal possessions. Residents may visit privately with their doctors, ministers, family, social worker, lawyer and others. Residents are entitled to send and receive mail unopened, and are entitled to use the phone in privacy. In addition, the nursing home cannot reveal personal, medical or financial information about residents without their permission except where a law expressly authorizes the disclosure.

- □ Practice their religion
- □ See their friends and loved ones
- Personal liberty: residents who want to leave are free to do so. Unless a court has declared them legally incompetent, it is illegal for nursing home staff to prevent residents from leaving to take a walk, shop or visit friends. They can advise that the person may not be strong enough, but they cannot physically restrain him/her or give the resident drugs that keep him/her incapable of going.

#### CIVIL COMMITMENT / RIGHT TO REFUSE TREATMENT

Throughout history, we have locked away many elderly people in mental hospitals against their will because they were forgetful or disoriented. Today's commitment laws, however, require a court finding that the person presents a likelihood of serious harm to him/herself or others before the person can be involuntarily confined. Harm can mean severe self-neglect, to the point that the individual is unable to survive safely in the community. Police or relatives may refer people for involuntary commitment. In addition, courts can remove the personal or financial decision-making rights of a person found to be "incompetent" or "incapacitated." When a person loses all or part of her decision-making ability, those decisions are transferred to a guardian or conservator. A person for whom the state seeks to appoint a guardian or conservator is entitled to a hearing, and even has the right to a jury trial, though it is seldom exercised. The person also has a right to a guardian ad litem to represent her interests during the proceedings. Further, the person has a right to appeal a ruling appointing a guardian or conservator. People who have been appointed a guardian or conservator may lose many basic rights:

- □ Right to contract
- □ Right to vote
- □ Right to marry
- □ Right to hold licenses



- □ Right to execute wills
- Capacity to sue and be sued

ACLU traditionally advocates the right of individuals to refuse treatment. The right to control one's body is one of the most fundamental rights one has. This is as true for people with mental disabilities as it is for people who do not wish to be kept alive by life-support devices. A competent person may execute a declaration directing the withholding or the withdrawal of life prolonging procedures. If family members disagree with a doctor's decision to remove or maintain life-support equipment, they should proceed through the hospital or institution's dispute resolution or ethics committee procedures, or hire an attorney to pursue a court order. In such cases the court will appoint a guardian *ad litem* to represent the patient's interests.
