DEFENDANTS' MOTION TO DISSOLVE THE TEMPORARY INJUNCTION

Defendants Tennessee Department of Safety and Homeland Security, Commissioner Jeff Long, and Assistant Commissioner Michael Hogan respectfully move for an order from this Court dissolving its preliminary injunction entered in the above styled case. As argued in the accompanying brief,¹ this Court imposed a temporary injunction on behalf of Petitioner Miller at a time it lacked jurisdiction, rendering that order void.

Moreover, Petitioner Miller failed to meet the four factors necessary for such extraordinary relief. Miller could not show any likelihood of success on the merits because Miller's claims

conflict with Tenn. Code Ann. § 1-3-105(c)'s clear definition of "sex" and the Department's statutory authority to enforce it. Miller failed to show irreparable harm, as a license that complies with Tennessee law is available to Miller without penalty. And the equitable considerations do not weigh in Miller's favor because the Department's statutory duties and the public interest in consistent enforcement of state law outweigh Miller's preferences.

The Court should grant the motion and dissolve the injunction.
